(Public Company) collects and uses the personal data you have provided in this request form for the purpose of verifying your identity as the data subject or representative, and processing your rights request. It may be necessary to disclose such personal data to other individuals or entities involved in processing your personal data, solely as required to fulfill your rights request. Such data will be retained until PPP Green Complex Co., Ltd. (Public Company) has completed processing your request, or until the process of contesting or refusing the data subject's rights request has concluded in cases where the Company is unable to fulfill your request for justifiable reasons as required by law or court order.
